Since 2019, 80 instructors have impacted more than 560 students and in 2023, we delivered 12,236 hours of instruction. We are so proud of what we have accomplished and yet there is a lot of work still to be done.

2023 was a year for strengthening existing partnerships and for developing new ones to improve and increase the impact of our services. We have nurtured our continuing relationships with schools such as Meade, Visitation BVM and Mastery-Wister Campus and are establishing new partnerships with organizations such as ESF Dream Camp and Moffett Elementary. 

What Makes Our Programs Unique?

High-Dosage literacy instruction; Wilson Reading System® Training; and focus on those most in need.

Reading Allowed is the **ONLY** literacy non-profit in Philadelphia to provide High-Dosage literacy instruction delivered by practitioners certified and experienced in structured literacy-based programs.



Of Philadelphia students living in poverty are reading at a proficient level.



Of students can learn to read proficiently when provided with high quality structured literacy instruction.



High-Dosage tutoring is one of the most effective ways to increase achievement for students from lower income families.



Students from low-income families are more likely to begin school already behind their more affluent peers and face challenges catching up.



Scientific research shows that High-Dosage tutoring can produce large learning gains for a wide range of students, including those who have fallen behind academically.



Of students interacting with the juvenile justice system are low literate.

Individual Structured Literacy Tutoring

In-School Partner Programs



Reading Allowed is the **ONLY** non-profit in Philadelphia to provide one-on-one structured literacy services on a sliding scale.



Reading Allowed partners with schools across Philadelphia to provide affordable structured literacy services.



In 2023, Reading Allowed's 80+ certified instructors served 170+ students across Philadelphia ranging from kindergartners to adults. Services were delivered in schools, libraries, community centers, and virtually.



In 2023, Reading Allowed expanded its in-school program to more schools. We served 150+ students attending schools in the School District of Philadelphia, charter, and Catholic schools in underserved neighborhoods.



Reading Allowed: By The Numbers



Our sliding scale 4th graders gained, on average **7.3 months of growth** in oral reading fluency **in the first four months** of this school year.

The changes I see in [my student's] academic performance, confidence and interest are invaluable. I was completely unsettled when we first found out about his [dyslexia] diagnosis. Now, seeing him bridge the gap to grade level reading puts me completely at ease! I hope that educators and parents will recognize the need for reading intervention techniques early and often.



School-based students progressed at a rate **7.8 times faster** than the norm. Reading Allowed students often begin their school year with a big deficit, and our instruction enables them to close the gap as fast as possible.

"When we met, this 15 year old 8th grader was very far behind. Now he can figure out how to break down words and get better grades. He got 100 on his reading and spelling test. He said he tapped things out and was figuring out how to break down the words, and that's why he was able to do so well! Of course, I was over the moon, jumping out of my seat to learn this... I LOVE MY JOB!!!!!


